Safety Warning Never attempt to disassemble or repair Doxie yourself. Contact Doxie Customer Care for assistance. Do not use Doxie near a fire or exposed to direct sunlight, nor near extreme temperatures. Do not use Doxie in a way that is not described in its user guide.
